The following information provides you with an overview of the processing of your personal data, **according to Regulation EU / 2016/679** (hereinafter "Regulation"). Italcanditi Spa (hereinafter "Company"), as Data Controller, intends to illustrate the purposes and the ways in which your personal data (hereinafter "Data"), conferred by you, are collected, used and processed in accordance with the execution of the current contractual relationships or in view of future business relationships.

<b>PERSONAL DATA PROCESSED</b>	'Personal data' means any information relating to an identified or identifiable natural person ('data subject') supplied by you or by the Society for which you work. The data processed are: - Personal data and identifiers data (included video surveillance) - Contact details - Data concerning current contracts or pre-contractual measures Your data are processed in digital and/or printed format conforming with the provisions of the Regulations and current laws
<b>PURPOSE OF PROCESSING</b>	We process your data lawfully, fairly and in a transparent manner in relation to the data subject ('lawfulness, fairness and transparency'); and their processing will be adequate, relevant and limited to what is necessary in relation to the following purposes: - to meet contractual obligations in the context of execution of our contracts with your Company or the implementation of pre-contractual measures Please note that the guest's registration is required filling in our external/visitors registration format. - Implementation of tax, accounting, and administrative compliance according with the requirements of the current legislation -If necessary to asserting legal claims or defend the controller rights in legal disputes
<b>LEGAL BASIS</b>	-Contract execution -Legal interest -Legal obligation compliance
<b>DATA STORAGE PERIOD</b>	The storage period of your personal data is limited in compliance to the purposes above: -execution of the contract: we process your data until there are contract obligations and until 10 years following this deadline in compliance with tax obligations. -In case of claims or legal disputes we storage your data until the end of legal actions -legal obligations: we storage your data until the legal obligations persist
<b>DATA COLLECTION</b>	The data collection is mandatory for the contract implementation and/or contact execution. The refusal to provide data not available, therefore, to establish the contractual relationship and / or to fulfill the consequent obligations.
<b>DATA RECIPIENTS</b>	-Data Controller could designate external subjects as Data Processors, who perform specific activities on behalf of our Company (for example, accounting, tax, insurance, management, etc.) -We could communicate to external subjects operating as data controllers (for example, authorities and supervisory and control bodies and in general public or private subjects entitled to request Data)
<b>PERSONS AUTHORISED TO PROCESS THE PERSONAL DATA</b>	Authorized employees of our company departments, who have received adequate operating instructions, could process your personal data for aforementioned purposes.
